

Privacy Notification GDPR for Dwellop AS

Dwellop AS focuses on safeguarding and protecting the privacy of all our customers and suppliers. We process personal data in accordance with applicable law, including the Personal Information Act and personal data regulations. Personal data are information and assessments that may be linked to you as a person, customer or supplier.

This privacy policy describes what personal information we receive and collect to provide the best possible products and services as well as what we do to protect your personal information.

You should familiarize yourself with the content of this privacy statement. By accessing our products and services, you consent to our processing of personal data in accordance with this privacy policy and the framework for which the applicable law is required at any time.

1 DATA COLLECTION

Dwellop AS is responsible for the processing of personal data in connection with all products and services provided by Dwellop as.

2 OUR USE OF PERSONAL DATA

2.1 Registration and collection of personal data

Dwellop AS processes the personal information you provide when registering with us and any information that you otherwise voluntarily provide from you, such as name details, address, email address, and phone number.

In addition, Dwellop AS will continuously register and process information about your customer relationship /supplier relationship with us, such as an overview of what has been purchased by products.

2.2 What your personal data is used for

We use the personal data in order to provide as good products and services as possible and to administer the customer relationship, conduct deliveries, service, product information, advertising management and invoicing.

3 STORAGE OF PERSONAL DATA

We store personal data in accordance with applicable law and have measures to ensure the confidentiality, availability and integrity requirements at any time.

Your personal data will only be stored for as long as Dwellop AS has a factual need for this and, under any circumstance, no longer than that arising from it at any time applicable legislation. When Dwellop AS no longer has a factual need for the storage of personal data, the information will be erased or anonymized.

4 DISCLOSURE OF PERSONAL DATA – CONFIDENTIALITY

We do not disclose personal data relating to you to outsiders except where disclosure of your personal data occurs:

- a. Pursuant to law or regulation granted by law,
- b. After the order of a court or other authority, or
- c. As part of payment collection etc. where objective reasons are present.

However, the confidentiality is not an obstacle to Dwellop AS making available the abovementioned personal data for those companies who, by agreement with Dwellop AS handles the technical or administrative operation of our services.

When we provide personal data to companies as mentioned herein, we ensure that these third parties adhere to Dwellop AS' requirements for the processing and use of personal data and at any time applicable law.

5. YOUR RIGHTS

You are entitled to access the information that Dwellop AS has registered about you at any time. You may also require rectification and deletion of personal data in accordance with applicable law.

6. REVISION OF THIS PRIVACY POLICY

We may change this privacy statement if:

1. Our processing of personal data changes, or
2. Auditing is deemed necessary due to change in laws or regulations given pursuant to law.

Dwellop AS will make any change clearly visible, but we generally recommend that you read this privacy statement periodically when visiting our websites.
